HOW IT WORKS

Solar panels catch sunlight and turn it into electricity. They make a special kind of power called "DC." This power goes to a device called an inverter, which changes it into the kind of power our homes use, called "AC."

Now, we can use this power to make our TV, fridge, and other machines work. If there's extra power, we send it to MSEDCL, like giving back extra electricity.

Here's an example: At noon, the solar system makes 10 units of power. But, we only need 3 units at that time. So, we use 3 units, and the extra 7 units go to MSEDCL. We can use these extra units at night when the sun isn't making electricity.

There's a special meter that keeps track of how much electricity we use and how much we give back. It's like a scorekeeper for electricity.

When we get our monthly bill, it depends on how much we used and how much we gave back. For instance, if we gave back 100 units and used 100 units, our bill is almost zero.

If we give back more than we use, the extra units go to MSEDCL, and we can use them in the next month. But if we use more than we give back, we might have to pay for the extra units we used.

So, solar power helps us use sunshine to power our home, and we can even share some with others!
