- **ISO 9001:2015**

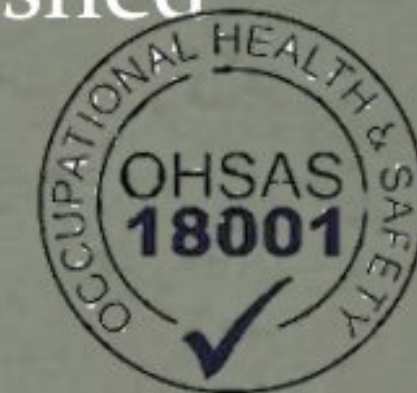

- ENVIRONMENTAL MANAGEMENT SERVICES (EMS): According to the International Organization for Standardization (ISO), an environmental management system describes the procedures used to manage environmental aspects, comply with legal requirements, and address risks and opportunities. There are specific standards that come in the field of the quality management system. Some are specified below;



- ISO 14001

This standard specifies requirements for an effective Environmental Management System (EMS). Instead of establishing environmental performance requirements, it provides a framework that organizations can follow. A company that wishes to set up, improve, or maintain an environmental management system in accordance with its established environmental policy and requirements should use ISO 14001.



- ISO 45001:2018: The Occupational Health and Safety Assessment Series, also known as OHSAS 18001:2007, is an international standard for occupational health and safety management systems. Compliance with it provided organizations with proof that they had occupational health and safety procedures in place.

- **ISO/IEC 27001:2013** : Information security management systems (ISMSs) are required to comply with ISO 27001, the only internationally recognized auditable standard.

An ISMS consists of policies, procedures, processes, and systems that manage information risks such as cyber-attacks, hacking, data leaks, or theft. As part

of ISO/IEC 27001:2013, the requirements for establishing, implementing, maintaining, and continuously improving an information security management system are outlined. The standard also contains the requirements for assessing and managing information security risks according to the needs of the organization.



- **ISO 22000:2018 FSMS**: A FSMS (Food Safety Management System) ensures that food is safe for consumption by controlling the food safety hazards in food businesses. It is mandatory for all businesses to put in place, implement and maintain a FSMS based on the principles of "Hazard Analysis Critical Control Point". In addition, it will provide products and services that are consistently safe, that meet all applicable statutory and regulatory requirements and that satisfy the interests of its customers; it will address risks associated with its objectives and demonstrate compliance with specified requirements in the FSMS.
