- **Device Installation:**

- Device Installation of Tracking Hardware(Teltonikafmb920) with One Year Software Subscription and Mobile Application.
- There will be a service charge of AED 150/each for device removal and installation in a different vehicle- (Only GPS Device).
- However, if the all vehicles are not available within 15 DAYS, we will submit the invoice for the completed job, we will not be responsible for the delay in getting the vehicle for the installation.
- Changing the device from one vehicle to another incurs a fee of 50 AED.

- **Device Warranty and Repair:**

We provide a comprehensive 1-year onsite warranty for all supplied products, ensuring prompt support and minimal downtime.

### **Warranty Coverage:**

- 1-Year Device Replacement Warranty: Faulty devices will be replaced free of charge within the warranty period.

#### • **Device replacement:**

- In the event that the device is determined to be faulty as a result of tampering or damage caused by drivers or users, a replacement can be obtained for a fee of 150 AED.

#### • **Lost or stolen vehicles:**

- If your vehicle is lost or stolen, the system can try to help you locate it by showing the location.
- We have an add-on by which vehicles can be immobilized remotely with our mobile app. We have given Immobilizer turn-on and off facility. To achieve this when installing a Teltonika GPS device we need to wire it in a certain way.
